PROGRAM REQUIREMENTS

ORGANIZATION REQUIREMENTS

- IRS 501(c)(3) non-profit for at least 12 months.
- Rated on Charity Navigator or GuideStar.
- Located in an area of a U.S. Panera Bread cafe.
- Alignment with the Panera Bread Foundation's mission and vision.

PROGRAM BENEFICIARY

- Children and youth ages 10-18.
- Students at-risk, underserved, low-income, or historically underrepresented.
- Predominately black, indigenous, or students of color.

TYPES OF PROGRAMS

- New, expanding, or continuing programs
- College and career readiness post-graduation
- Learning hard and soft skills
- Mentorship to build healthy relationships
- STEM-related programs
- Youth leadership development

NOT ELIGIBLE

- Schools, religious and faith-based organizations, municipalities, individuals.
- Political organizations.
- One-time events, fundraising events, catering donations.
- Unlawful or discriminatory practices.

FREQUENTLY ASKED QUESTIONS (FAQ'S)

1. Which Panera cafe should I choose if our organization has multiple locations?

Use the zip code for your main location or your largest site.

2. What schools do not qualify?

Public schools, religious-based schools, colleges and universities.

3. Do fiscally sponsored organizations qualify?

Not at this time.

4. Can national organizations and their chapters apply for a grant?

Yes. Both the national organization and individual chapters are eligible to apply.

5. Can our organization submit more than 1 application?

No. Please complete only 1 application per organization.

6. What should I do when our organization's 990 exceeds the attachment size?

- If your 990 is available online, please provide a link to your 990 in a document.
- If your 990 is not available online, we recommend compressing the PDF to upload.

7. What is our organization's annual operating budget?

Your organization's expected revenues and expenses over 12 months.

8. Is our organization eligible to apply if we have applied before and/or received grant funding in a prior year?

 Yes, we welcome both prior applicants and recipients to submit a new application for this grant cycle.

9. Can we meet with your team before, during, or after we apply?
